Trauma, loss and attachment seminar series with Kim Golding:

Seminar A - Trauma and attachment: Supporting children who have experienced developmental trauma leading to difficulties in attachment:

Attachment theory revised: understanding the relationship between trauma and attachment; the relationship between early traumatic attachment development and later behavioural and relationship difficulties; the influence of early trauma experience and later attachment relationships; ideas about therapeutic parenting for developmentally traumatized children (Dance of Attachment, House Model of Parenting)

Seminar B - Attachment theory: Its application to adolescence and young adulthood:

Increase your understanding of attachment theory and the process of attachment through childhood and adolescence; apply this understanding to working with young adults; explore the implications of this for practice. This includes infant development and experience and its impact on adolescence.

Seminar C - Working therapeutically with children with attachment difficulties:

Increase your understanding of attachment theory and its application in therapies; explore the theoretical principles underlying attachment focused therapies; explore a range of therapies including therapeutic parenting interventions and child carer interventions (inter-subjectivity, parent-infant psychotherapy, understanding and managing shame)

Seminar D - Dyadic developmental psychotherapy with children with attachment difficulties:

Increase your understanding of attachment theory and its application in dyadic developmental psychotherapy; explore the theoretical and clinical principles underlying DDP, explore the understanding and management of shame-based difficulties (inter-subjectivity, co-regulation of emotion, PACE, co-construction of meaning).

About Kim Golding ...



Kim is a consultant clinical psychologist with a longstanding interest in parenting, and collaborating with parents or carers to develop their parenting skills tailored to the particular needs of the children they are caring for. She has a special interest in supporting foster carers and adoptive parents.

Kim was involved in the setting up and evaluation of an inter-agency project in Worcestershire, UK. This team is now part of the Integrated Service for Looked After and Adopted Children (ISL). ISL is a multi-agency, holistic service, jointly provided and managed by Health and Children's Services. The service provides support for foster, adoptive and residential carers; schools; and the range of professionals around the child growing up in care. Within this service Kim has implemented a range of interventions based upon attachment theory and has carried out research

exploring the use of a consultation service for foster carers and other professionals.

Kim works closely with Dan Hughes and is involved in developing his ideas for the United Kingdom. She and Dan are currently collaborating on writing a book due to be published in 2012.
