##### ***Innovation and Collaboration***

Highlighting the creative and collaborative efforts individuals and organisations have made to achieve successful outcomes for the safety and wellbeing of children.

##### ***Contribution to the Sector***

Acknowledging the outstanding contributions individuals have made to the Child Protection Sector over an extended period of time.

##### ***Newcomer***

Highlighting the efforts of Individuals that have commenced in the sector during the past 18 months.

#### ELIGIBILITY CRITERIA:

- Award winners will have demonstrated exceptional commitment to prevention of child harm or the promotion of the protection of children and young people.
- Nominees' achievements must be in accordance with the principles of the *Child Protection Act 1999*.
- Nominees may undertake the nominated project/achievement as part of work-related duties or community services.
- The judging panel reserves the right to change the category under which the nomination is being considered if the submission is deemed to be more appropriate to another category.
- The judging panel reserves the right not to present an Award in a category if it feels there are no suitable submissions.
- Nominees may be individuals, groups or agencies according to the particular Award.
