The **National Disability Insurance Scheme (NDIS)**

is due to be introduced in Queensland from 2016. While we don't know all of the details yet, this initiative does bring an opportunity for people with disability, and the people closest to them, to have a greater say over their support arrangements. This potential will only be achieved if people are well prepared for this major change.

In this one day seminar, Dr Kendrick will explore what people with disabilities, and the people who support them, can do **now** in order to ensure that people with disabilities benefit from this opportunity.

He will explore topics such as self-direction; choice; control over funding; what support could look like and the contribution of family and friends.

The seminar will offer practical strategies on where to start and how we might design and create support that suits the person and that is sustainable over time. Safeguarding these support arrangements will also be covered.



Presenter:

Dr Michael Kendrick is well known internationally as an educator, advocate, consultant and author. He has worked in government and non-government agencies and consults on issues such as service quality, safeguards, and design of personalized services. He lives in the United States, but as a regular visitor to Queensland he understands the local and national issues that people with disability and their supporters face as they strive to live in their community.
