





Free legal help to navigate the Royal Commission

A Royal Commission has been set up to investigate child sexual abuse in institutions such as government agencies, churches, missions and foster care, and how those institutions responded.

**knowmore** is a culturally safe legal service that is completely separate from and independent of the Royal Commission and government.

If you think that this might be the right time and place for you to tell your story or provide information, **knowmore** provides free and confidential legal advice about your options for talking with the Royal Commission, and about related issues such as confidentiality agreements and compensation.

We have Aboriginal staff to listen to and support you.

**knowmore** acknowledges the traditional owners of the lands across Australia upon which we live and work. We pay deep respect to Elders past and present.

# **knowmore** and the Royal Commission into Institutional Responses to Child Sexual Abuse

**knowmore** is a free legal service that provides confidential legal advice about your options for talking with the Royal Commission, and about related issues such as confidentiality agreements and compensation.

The Royal Commission is interested in hearing from people who were sexually abused as children, or who witnessed child sexual abuse, in institutions. The abuse can have occurred at any time.

**knowmore** is here to help you understand your options in speaking with the Royal Commission and can provide practical assistance such as helping write statements or submissions if you choose to tell your story.

**knowmore** provides a culturally safe and respectful service to anyone who seeks our help.

**knowmore** has been established by the National Association of Community Legal Centres, with funding from the Australian Government represented by the Attorney-General's Department.

**knowmore** recognises that some Aboriginal and Torres Strait Islander people live in remote and regional areas, so if you need someone to come and speak in your community, let us know by calling 1800 605 762.



knowmore employs Aboriginal and Torres Strait Islander engagement advisors who have many years experience supporting survivors of sexual abuse, violence and institutional abuse.
